
Properties can be let if they have an energy rating from A to E.

## **Energy rating and score**

# How this affects your energy bills

1. Increase loft insulation to 270 mm	£100 - £350	£52
2. Floor insulation (solid floor)	£4,000 - £6,000	£110
3. Add additional 80 mm jacket to hot water cylinder	£15 - £30	£29
4. Low energy lighting	£15	£13
5. High heat retention storage heaters	£800 - £1,200	£277
