Contract Holder (Tenant) Fees with effect from 1st September 2019:

Permitted payments

For properties in Wales, the Renting Homes (Fees etc.) (Wales) Bill means that in addition to rent, lettings agents can only charge contract holders (or anyone acting on the contract holder's behalf) the following permitted payments:

Holding deposit: A maximum of 1 week's rent.

<u>Deposits:</u> Equal to 5 weeks rent (Rounded down to the nearest £, unless stated different on an individual property).

<u>Utilities</u>: Communication services (e.g. telephone, broadband), TV licence and council tax; including installation and subscription to cable/satellite suppliers.

<u>Default payments</u>: For breach of the contract e.g. missed appointments or lost keys up to the prescribed limits

Any other permitted payments under the Renting Homes (Fees etc.) (Wales) Bill and regulations.

Contract holder protection

Prospective Contract holders: PLEASE BE AWARE of the Process:

When looking for your next home the first stage is to view (after ensuring you have sufficient finances to cover the rent and outgoings for the house you're seeking).

Once you've found a property with us the next step will be to apply for the property that will involve making an application, paying a holding deposit and processing referencing.

NOTE – once passed referencing, this does not mean you can move in. The next stage will be for our property management department to make sure the property is contract holder ready, e.g checking safety regulations, preparing or updating the inventory, processing the paperwork etc. This usually would be 7 – 10 days after you've passed referencing.

Then we all should be ready to sign the contracts, execute the tenancy and "exchange contract". It's at this stage the monies due are paid, and a completion (Move In) date is agreed.

So, please be aware, from application to move in, it could be around 2 – 3 weeks. (Sometimes less, sometimes more depending on circumstances).
